What is this type of insurance?

This Policy covers cover your permanent and temporary works on a single or annual basis against accidental/malicious loss, destruction or damage



What is insured?

- ✓ Damage to the permanent works caused by the contractor during the maintenance or defects liability period
- ✓ Indemnifies your employer/purchaser/principal
- ✓ Cost of professional fees incurred in reinstating the property following a loss is covered provided the sum insured is adequate – excluding costs of claim preparation
- ✓ Costs incurred in removing debris, dismantling and/or demolition and shoring or propping up of damaged property are covered within the sum insured for a limit of up to 10% of Limit of Indemnity
